### General Terminal Fees

For each use of the terminal building the following per seat fee applies

\*A domestic flight means a flight arriving from a destination within Canada that does not have disembarking passengers+ or aircrew required to report pursuant to the Customs Act.

\*An international flight means a flight arriving from a point outside Canada or a domestic flight from which disembarking passengers or aircrew are required to report pursuant to the Customs Act.

### Aircraft Landing Fees

All fees are charged per 1,000 kg portion or fraction thereof the Maximum Certified Take-off weight of each jet, turboprop or helicopter aircraft landing at YYJ. There is no difference between domestic or international flights.

\*Minimum landing fee is \$19.03

### Aircraft Parking Fees

Itinerant parking fees are charged on all aircraft parking on Apron IV for periods over four hours. Parking for more than four hours but less than 24 hours is counted as one day.

### Airport Improvement Fees (AIF)

Passengers departing from Victoria International Airport via commercial aircraft are required to pay an Airport Improvement Fee of \$25 per each eligible departing passenger for inter-provincial, transborder or international flights.

The fee is collected by the respective airline at the time of ticket purchase and must be remitted to VAA monthly.
